Privacy Policy

1. Introduction

Welcome to Rootz ("we," "our," or "us"). This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you visit our website https://www.rootz.website and participate in our cashback referral program. Please read this privacy policy carefully. If you do not agree with the terms of this privacy policy, please do not access the site or use our services.

2. Information We Collect

2.1 Personal Information

We may collect personally identifiable information that you voluntarily provide when you:

- · Register for an account
- Participate in our referral program
- Make purchases through our platform
- Contact us for support
- Subscribe to our newsletter

This information may include:

- Full name
- Email address
- Phone number
- Postal address
- Payment information (processed through secure third-party processors)
- Bank account details for cashback payments
- Social media profiles (if used for sharing referral links)

2.2 Referral Program Information

When you participate in our 3-level cashback referral system, we collect:

- Referral links and codes you generate
- Information about users you refer (up to 3 levels deep)
- Purchase history and transaction amounts of referred users
- Cashback earnings and payment history

· Referral relationship mapping

2.3 Automatically Collected Information

We automatically collect certain information when you visit our website:

- IP address and location data
- Browser type and version
- Device information
- Pages visited and time spent
- Referring website information
- Cookies and similar tracking technologies

2.4 Third-Party Information

We may receive information about you from third parties, including:

- · Partner merchants and retailers
- Payment processors
- Social media platforms
- Analytics providers

3. How We Use Your Information

3.1 Primary Uses

We use your information to:

- Operate and maintain our cashback referral program
- Process and track referral relationships across 3 levels
- Calculate and distribute cashback rewards
- Verify purchase eligibility and prevent fraud
- Send you important account and service updates
- Provide customer support
- Process payments and manage your account

3.2 Referral Program Operations

Specifically for our referral system, we use your information to:

- Track referral relationships and subsidiary purchases
- Calculate multi-level commission structures

- Generate personalized referral links and codes
- Monitor referral program performance and compliance
- Prevent abuse and fraudulent referral activities

3.3 Communications

We may use your information to:

- Send referral program updates and earnings statements
- Notify you of new partnership opportunities
- Provide promotional offers and marketing materials
- Send administrative communications about your account

4. Information Sharing and Disclosure

5. Referral Program Specific Disclosures

5.1 Multi-Level Tracking

Our referral program tracks relationships across 3 levels. This means:

- Level 1: Direct referrals you make
- Level 2: Referrals made by your direct referrals
- Level 3: Referrals made by Level 2 participants

Each level may earn you different commission rates as disclosed in our program terms.

5.2 Purchase Tracking

We track purchases made by users in your referral network to calculate your cashback earnings. This includes:

- Transaction amounts and dates
- Product categories purchased
- Merchant information
- Return and refund activities

5.3 Performance Analytics

We analyze referral program performance and may use aggregated, anonymized data for:

- Program optimization
- Trend analysis
- Marketing effectiveness studies
- · Industry reporting

6. Data Security

We implement appropriate technical and organizational security measures to protect your personal information, including:

- Encryption of sensitive data in transit and at rest
- Secure payment processing through PCI-compliant providers

Referral relationship data may be retained longer for commission tracking and tax reporting purposes.

9. International Data Transfers

If you are located outside our primary jurisdiction, your information may be transferred to and processed in countries with different data protection laws. We ensure appropriate safeguards are in place for such transfers.

10. Children's Privacy

Our services are not intended for individuals under 18 years of age. We do not knowingly collect personal information from children under 18. If we discover we have collected information from a child under 18, we will delete it immediately.

11. Third-Party Links

Our website may contain links to third-party websites. This privacy policy does not apply to those sites, and we are not responsible for their privacy practices.
