1. Introduction

This Cookie Policy explains how Rootz ("we," "our," or "us") uses cookies and similar tracking technologies on our website https://www.rootz.website and related services. This policy should be read together with our Privacy Policy.

By using our website and services, you consent to the use of cookies as described in this policy. If you do not agree to our use of cookies, you should set your browser settings accordingly or not use our website.

2. What Are Cookies?

Cookies are small text files that are placed on your device (computer, smartphone, tablet) when you visit a website. They are widely used to make websites work more efficiently and to provide information to website owners.

Cookies contain information that is transferred to your device's hard drive. They help us recognize your browser and capture certain information about your preferences and usage patterns.

3. Types of Cookies We Use

3.1 Essential Cookies

These cookies are necessary for our website to function properly and cannot be switched off. They are usually set in response to actions you take, such as:

Duration: These cookies may remain active for up to 90 days to ensure proper attribution of purchases and referrals.

• **Medium-term**: 30-90 days (referral tracking)

• Long-term: 1-2 years (analytics and advertising)

6.3 Referral Tracking Cookies

• Standard duration: 30-90 days

- Ensures proper attribution of purchases to referrals
- · May be extended for high-value transactions
